The Anson County Board of Education met in regular session on Monday, November 23, 2020. Members present via Virtual Go To Meeting were Marilynn Bennett, Lisa Davis, Bobbie Little, Frank Liles and George Truman. Leadership Team Members were also present.

Call to Order

Dr. George Truman opened the meeting at 4:03 p.m. and welcomed everyone in attendance.

Invocation

Mike Turner gave the Invocation.

Conflict of Interest Statement

In compliance with the requirements of Chapter 138A-15(e) of the State Government Ethics Act, Chair George Truman reminded Board Members of their duty to avoid conflicts of interest and appearances of conflicts of interest under Chapter 138A. Chair's Report

Public Engagement:

Gay Lookabill said the high school has done well with sharing information on viewing home athletic games for fans that can't attend due to restrictions. Dr. Truman asked for the information to be put on our website and social media about viewing the home athletic events. Mr. Turner acknowledged the Bright Ideas Grant Winners. Mr. McLean said he will be sure they get recognized once he receives official notice. Dr. Truman advised for a letter to be sent on behalf of the board to the recipients and he said he will work with Mr. McLean on that letter. There were no other public engagement opportunities mentioned by board members.

Superintendent's Report

Mr. McLean gave a report on Budget, Human Resources, Current Job Postings and Instructional/Operational Programs.

Mr. McLean stated Plan B is working well and we will continue until we go a different direction. Gay Lookabill said she liked how some schools shared the positives and negatives in bulleted information when giving updates to the board.

Questions & Answers from the Board:

Mr. Turner asked if there would be a basketball season. He asked what must change to allow those seasons to happen. Mr. McLean said getting numbers down will give us more options throughout the district and the state.

Ms. Gibson asked why meals can't be delivered. Mr. McLean said because we are using buses to pick up students and we can't use buses to deliver meals as well. He said they will need to make decisions on curbside because numbers are down. Gay Lookabill asked if activity buses could be used for meal delivery. Mr. McLean said not to his knowledge but he will check. Ms. Davis asked if we could use CARES Act money to pay for double trips for yellow buses to deliver meals. Mr. McLean stated he would check.
